Big Setback to Sharad Pawar, EC Gives NCP Symbol to Ajit Faction

New Delhi: The Election Commission of India has handed over the Nationalist Congress Party (NCP) name and symbol—the analogue clock—to the Ajit Pawar faction on the basis of the 'Test of Legislative Majority'.



The poll panel's decision on the symbol row comes just ahead of Lok Sabha elections and amid the Parliament session. However, as a concession, the poll panel has allowed the Sharad Pawar faction to opt for a name for a new political formation by Wednesday to be able to contest upcoming Rajya Sabha elections to six seats in Maharashtra. **HOW SHARAD PAWAR FAILED THE EC TEST** Following a NCP split in 2023, the matter came to the poll panel which has held ten hearings with the two factions since 01.07.2023. The traditional three key tests were deployed by ECI to determine the symbol dispute—tests of aims and objectives of party constitution, test of party constitution and test of majority—both organizational and Legislative. The first two failed to yield any clarity as in the first there was no dispute and in the second case, none of the frivolous actions were found to be following the party constitution by the ECI. Accordingly, the test of majority was applied. However, the Sharad Pawar faction was unable to establish its organisational majority due to 'absence of any coherent or substantial document' brought on record by them, says the ECI order. The test of legislative majority proved determinant with 51 verifiable affidavits of the 81 legislators were found in support of the Ajit Pawar faction via a vis the 28 submitted by the Sharad Pawar faction, the poll panel's order shows. However, in view of the upcoming Rajya Sabha polls where six seats from Maharashtra are up for election, a special concession has been allowed to the Sharad Pawar fac-

tion to be able to contest in compliance with Rule 39AA of Conduct of Elections Rules 1961. Under Para 18 of the Symbols Order, the ECI has given the Sharad Pawar faction a onetime option to claim a name to its new political formation and provide three preferences to the Commission by Wednesday. The implications of the para 15 of the symbol order, i.e. the ruling as laid down in the matter of amalgamation of Indian Congress (socialist) and Nationalist Congress Party, ECI order of Aug 4, 1999 was relied upon in the present matter pertaining to Rajya Sabha elections.

ECI WARNING-NO 'PERSONAL FIEFDOM' PLS The ECI, however, has gone beyond the NCP symbol dispute in its 141-page order to point out that the majority of symbol disputes before it show that either political parties are not holding regular internal elections or not holding them as per party constitution or have amended their constitution in such a way that 'elections' have become 'appointments'. The poll panel has said this not only renders the tests of party constitution and organisational majority redundant in a symbol dispute but end up turning parties into 'personal fiefdoms' run like a private enterprise that is out of touch with its rank and file. The ECI had advised all political parties to take note of the same and adopt good disclosure practices on their organisational elections and elected officer bearers among other aspects.

Accept EC Decision With Humility, Says Ajit Pawar

Mumbai: Maharashtra deputy chief minister Ajit Pawar on Tuesday said he "accepts with humility" Election Commission's ruling to declare his faction as the real NCP. The NCP leader's reaction came shortly after the poll panel announced that the Ajit Pawar faction is the real Nationalist Congress Party (NCP). The Election Commission's ruling ended months of speculation over the factional fight between Ajit Pawar and party founder and his uncle Sharad Pawar. The Commission also allotted the NCP symbol 'wall clock' to the group led by Ajit Pawar. The decision followed the laid-out tests of maintainability of such a petition which included tests of aims and objectives of party constitution, test of party constitution and tests of majority both organisational and legislative, the commission said. "The test of majority in the legislative wing found favour in this circumstance of the case, where both groups have found to be working outside the party constitution and the organisational elections," the poll authority observed.—PTI

IAF to Get New Mid-air Refuellers And Signal Intelligence Aircraft

New Delhi: The air force is likely to get much needed mid-air refuellers that act as crucial force multipliers, with the ministry considering a Rs 10,000 crore proposal to acquire six of the aircraft. Plans to acquire three airborne intelligence gathering aircraft under a project that will see the development of indigenous sensor technologies and systems are also likely to move ahead. Sources said that the proposal to acquire six mid-air refuellers—a long pending requirement of the air force that dates back to 2009—could see some forward movement. Being processed under the 'Buy Global' category given the limited numbers needed, the proposal could see pre-owned aircraft being converted into mid-air refuellers to meet the urgent demand.

them to tankers, which requires precise engineering and certification, could be done in India with local partners. Forward movement is also expected on a Rs 6,000 crore project for three new airborne intelligence, surveillance, target acquisition and reconnaissance platforms vital to map out battlefields and monitor enemy movements in real time. Under the project, the sensors and monitoring equipment will be indigenously developed with the Defence Research and Development Organisation (DRDO) as the lead agency and the aircraft will be a commercial/executive jet acquired from abroad. Along with UAVs, the platform will enable tracking of enemy assets across the border, signal intelligence gathering and pinpointing enemy radar and air defence positions. It will also be able to intercept and jam enemy signals.

ED Raids Delhi CM's Aide, AAP MP, Others

New Delhi: The Enforcement Directorate (ED) on Tuesday raided around a dozen premises linked to Bibhav Kumar, Delhi chief minister Arvind Kejriwal's personal secretary; N D Gupta, AAP Rajya Sabha MP; Shalabh Kumar, former Delhi Jal Board (DJB) member and others in connection with a money laundering probe pertaining to the Delhi Jal Board case. According to the agency, Jagdish Kumar Arora, the then chief engineer of the DJB allegedly awarded a contract for the supply, installation, testing and commissioning of electromagnetic flow meters to NKG Infrastructure Ltd. for a total cost of ₹38 cr; despite the company not meeting the technical eligibility criteria. The agency has alleged that its probe revealed that NKG Infrastructure Ltd. secured the bid by submitting forged or false documents. The ED has further alleged that NKG Infrastructure Ltd. subcontracted the work to Integral Screws Ltd., a firm owned by Anil Kumar Aggarwal who allegedly transferred around ₹3 cr as a bribe to Jagdish Kumar Arora through various means, including cash and bank transactions.

AMID RAIDS ON AAP LEADERS Atishi Says Audio Footage Deleted; ED Vows to Sue

New Delhi: Aam Aadmi Party (AAP) minister Atishi on Tuesday alleged that the Enforcement Directorate (ED) was using coercion to threaten witnesses to speak against the AAP leaders so that cases can be filed against them. The allegation triggered a war of words between the ED and the political party. "ED is coercing, threatening people to give false statements against AAP leaders in the excise policy case," she said during a press conference, and added, "ED raids on AAP leaders are being carried out to silence the party." Atishi also accused ED of deleting audio recordings of witness statements. "For the last two years, AAP leaders are being threatened. In the name of this so-called liquor scam, someone's house is raided,



someone gets summons and someone is arrested... Even after hundreds of raids in two years, ED has not been able to recover even a single rupee. Even after two years, ED has not found any concrete evidence and the court has also repeatedly asked that evidence be presented..." ED, however, termed the allegations as false, baseless and malicious and said it is considering legal action against Atishi. ED slammed AAP saying, "Baseless allegations are trumped up daily by its leaders just to discredit the evidence against their misdeeds." All statements of the accused were recorded under CCTV surveillance and the same were supplied to the accused persons as sought by them and the trial court was also provided the same, ED said.
